# Rehabilitation Care Coordination

## **BENEFITS**

**Medicare:** Health insurance program available for individuals age 65 or older, younger people with disabilities and those with End Stage Renal Disease (permanent kidney failure requiring dialysis or transplant). You can qualify for Medicare coverage automatically after you've received disability benefits for two years.

**Medi-Cal:** California's Medicaid program. Provides medical and dental services for children and adults with limited income and resources.

**Social Security Disability Insurance (SSDI):** Provides income supplements to those who are limited in their ability to be employed because of a notable disability for 12 months or longer. You can receive benefits based on your work record, your parent's work record or a deceased spouse's work record.

**Supplemental Security Insurance (SSI):** Provides financial aid for those with limited financial resources who are either 65 or older, are disabled and/or blind.

**In-Home Support Services (IHSS):** Provides homemaker and personal care assistance to individuals who receive Medi-Cal or who have low income and need aid to remain independent in their home. Eligibility is based on financial guidelines, if the individual is blind, disabled or 65 and older, and unable to live at home safely without help.

**CalFresh:** California form of the federal Supplemental Nutrition Assistance Program (SNAP). Provides financial aid for people with low income to assist in the purchase of food. Recipients of SSI are eligible as well. Funds are provided through EBT cards on a monthly basis and can be used at any participating store.

**Regional Center:** A program for persons with disabilities in the State of California. These centers were originally established to assist persons and their families with intellectual disabilities, cerebral palsy, epilepsy & autism in locating services and programs within their communities. Disability has to occur prior to age 18. To apply, search for the local county office at [www.regionalcenter.org](http://www.regionalcenter.org) then call to start the intake process. Other states may have similar programs under a different name.

**Department of Rehabilitation (DOR):** Provides services and advocacy for individuals with disabilities to live independently, become employed and have equality to the communities in which they live & work. DOR provides consultation, counseling and vocational rehabilitation, and works with community partners to assist the consumers they serve.
